**FINANCIAL REPORT:** Duane Scott reported the total balance in all the accounts was \$5,234,422.86 at March 21, 2019 compared to the balance of at \$5,186,707.04 at February 20, 2019. \$0 was disbursed during the month. Ryan stated the Churchhill has been invested since February, question was asked regarding the \$102.24 in the Nash Scholarship Fund, this was because a dividend came in before the Account closed. - A.) Scholarship Committee – Susan stated that the Scholarship Committee has received the following Scholarship application: 28 Dewelle, 11 girls and 12 boys for the Stem, 11 Nash and 7 Provident-Salierno and at least one from each one of the high schools. For the first time ever we received 6 vocational scholarship, usually we only receive these from COS,

These came in from El Diamante and Golden West. COS was informed that the vocational scholarships will be down from \$15,000 to \$12,000 this year due to the amount of money being down. After speaking with Tim from COS, they understand that the amount has been reduced.
